### **OBJECTIVES:**

FBR issued new procedure for filing of sales tax return from July 2016 and onward. The aim behind the new Sales Tax Return mechanism is to simplify the system for payment of taxes through automated system and to minimize contact between the taxpayers and the tax collectors. The mechanism of CREST will also be changed due to drastic changes made in the new sales tax return especially matters relevant to sales, purchases, withholding of sales tax, debit credit notes etc.

Now it is considered mandatory for a person preparing or handling matters relevant to the sales tax return to have indepth knowledge of procedures involved in preparation and submission of new sales tax return especially to handle the critical issues involved in it.

Looking at the need of the time and recent changes made in Sales Tax Return, Softax arranged a full day workshop on "E-filing of new Sales Tax Return". ## Sales Tax Real-time Invoice Verification

A new Version of Sales Tax Return system is launched by FBR on 26th Jul 2016. This System is applicable from Tax Period July 2017 Sales Tax Return due in Aug 2016.

The system is based on early submission of sales invoices and then selection of already submitted data for purchase credits. New features in system are aimed at facilitation of taxpayers through automation.
