Withholding taxes seems to be the significant contributors to the national exchequer and has been on rise over the years. During a study, FBR observed that visible gaps exist between the actual collection of withholding taxes by the withholding agents and their true potential. A large number of deficiencies in the system and management of Withholding taxes at the end of Withholding Agents is considered to be the main cause of the gap. To bridge the gap, FBR planned to monitor withholding tax transactions through different modes and select the cases of Withholding Agents for AUDIT.
