OBJECTIVES

Federal Government is making day by day changes in Withholding taxes, like increasing number of transactions subject to withholding tax, responsibilities of withholding agents including integration with FBR System and penalties. The Withholding agents are burdened day by day to collect more than 75% of the revenue from direct taxes, resultantly facing lot of problems in handling withholding tax matters specially, departmental proceedings, who/how/when a withholding agent shall deduct etc. Furthermore, concept of Filer / Non-Filer, Active/Inactive and rapid changes in the rates of taxes created another problem for the Withholding Agents to identify the category of taxpayer and applicable tax rates.
