## **OBJECTIVES**

Withholding taxes seems to be the significant contributors to the national exchequer and has been on rise over the years. During a study, FBR observed that visible gaps exist between the actual collection of withholding taxes by the withholding agents and their true potential. A large number of deficiencies in the system and management of Withholding taxes at the end of Withholding Agents are considered to be the main cause of the gap. To bridge the gap, FBR planned to monitor withholding tax transactions through different modes and select the cases of Withholding Agents for AUDIT.

Similarly, Federal & Provincial Revenue departments have turned to withholding agents for non-compliances of Sales Tax Withholding. Considering it a high time, Softax have planned a full day workshop which aims at to review, discuss and understand each and every aspect Income Tax & Federal/Provincial Sales Tax withholding tax transactions and mechanism, like; omission of certain withholding tax transactions, impact of changing certain regimes from final tax to minimum tax, responsibilities of withholding agents including preparation of periodical withholding statements etc. Further, the participants will be equipped to handle with confidence the day to day issues of Withholding tax matters, like number of transactions subject to withholding tax, scope of withholding agent and penalties, who/how/when a withholding agent shall deduct and then to whom deposit and reverse charge in provincial sales tax laws.

In addition to above, this session also aims at to resolve day to day practical issues of the Withholding Agents including multiple monitoring sessions for the same tax year u/s 161 and harsh recovery proceedings.

At the end of the session, participants will not only be updated with changes in Withholding Tax Laws but will also be able to handle their day to day withholding tax matters in a professional manner, resultantly the compliance level will be improved and chances of heavy penalties and prosecution will be minimized.
