

### WORKSHOP OBJECTIVES

Sales Tax Laws in Pakistan are based on Value Added Tax (VAT) System. The implication of VAT Scheme in true letter and spirit helps in covering all the commercial activities and to broaden the tax net. This also results in documentation in the whole supply chain. VAT promotes economic documentation with the help of its in-built invoice-based credit mechanism. VAT has self-enforcing features to document the business transaction through tax invoicing. The world experience shows that VAT induces a strong tax culture.

Generally, worldwide there is no concept of withholding of sales tax under VAT mechanism, but in Pakistan all the Federal and Provincial Authorities using withholding of sales tax as a revenue tool instead "tool to broaden tax net".

Resultantly, the withholding agents which commonly includes Federal and Provincial Government Departments, Companies, Banks,

Non-profit and Public sector organizations facing lot of legal, technical and financial issues including undue litigation hassle and cost. So, looking at the seriousness of above issue, Softax arranged a full day workshop on Withholding taxes under Federal & Provincial

Sales Tax Laws. During the session, in addition to general understanding of withholding tax transactions, the main focus will be on the critical issues, especially in the case of inter province transactions, where main challenge for withholding agent is to determine that who will deduct the tax and to whom deposit and for the sales tax and to whom deposit service provider, how to get adjustment of tax withheld in other provinces.
