WORKSHOP OBJECTIVES

Non Profit Organization (NPO) is a setup in which no owner, shareholder or trustee shares in profits and losses, and which exists not to earn profit but to promote a mission that enhances the public welfare. These organizations are eligible for 100% tax credit subject to fulfillment of few conditions as prescribed in the Income Tax Ordinance, 2001.

100% tax credit under Income Tax Ordinance, 2001 does not mean exemption from all taxation laws. Some activities of Non Profit Organizations are taxable under existing applicable tax laws and NPOs are required to comply with it, because "ignorance of law is no excuse".

The workshop aims at to address practical matters relevant to taxation of NPOs under Income Tax Law and Federal/Provincial Sales Tax Laws, which will be discussed in detail to ensure timely compliance of conditions to avail 100% tax credit under the Income Tax Ordinance, 2001 and to avoid burden of undue taxes, penalties and cost of litigation.

At the end of the session the participants will be able to handle day to day income tax and sales tax matters of a Non-Profit Organization and to make the required changes in their existing taxation system in a professional manner.
