OBJECTIVES

Withholding agents are burdened day by day to collect more than 75% of the revenue from direct taxes, resultantly facing lot of problems in handling withholding tax matters specially departmental proceedings and who/how/when a withholding agent shall deduct tax etc. Furthermore, concept of Filer / Non-Filer, Active/Inactive and rapid changes in the rates of taxes created another problem for the Withholding Agents to identify the category of taxpayer and applicable tax rates.
